Heating Oil Prices

Augusta--- The Governor’s Office of Energy Independence and Security (OEIS) conducted its weekly oil survey and found that the current statewide average cash price for No. 2 heating oil to be at **\$2.61 per gallon**, up three cents from last week.

“Despite negative economic news in the recent jobs report, crude oil prices remained above \$80 per barrel for the second week in a row,” said OEIS Director John Kerry. “While U.S. companies hired fewer workers than forecast last month, an anticipated economic rebound combined with climbing global demand will likely push crude and heating oil prices upward. People should take immediate action to prepare for this winter’s heating season.”

It is important to note that the price for heating oil is a statewide average and that prices in a given geographic region of the state may be considerably higher or lower than the statewide average. Within the OEIS sample, the lowest actual heating oil price of \$2.40 per gallon was found in the Southwest and Western regions. The highest price of \$2.87 per gallon was found in the Northern region. The statewide kerosene price average is \$2.96 per gallon at this time. The statewide average for propane based on a use of 600 gallons a year is \$2.57 per gallon. The table above provides current Maine cash prices in dollars rounded to the nearest penny. At the time of this release the price of WTI crude oil, a major driver of refined product prices, including heating oil was \$81.41.
