# Charging and Fueling Infrastructure Grant Program

MaineDOT is applying for up to \$10 million per year from the Federal Highway Administration (FHWA) Charging and Fueling Infrastructure grant program (CFI) to support Recharge Maine, the statewide initiative to expand <u>public level 2 and DC fast</u> charging in Maine.



MaineDOT will submit a <u>single statewide grant application</u> for this program. Individual municipalities are eligible to apply directly to FHWA if they wish to pursue funding separately from the Recharge Maine effort.

Priority locations for the Recharge Maine grant application will include:

- Rural areas
- Locations in or near disadvantaged communities, as defined by the USDOT Electric Vehicle Charging

- Communities with a high concentration of multi-unit dwellings (MUD)
