This promotion is available for the first 50 cars and the first 50 work vans on a first-come-first-served basis for Maine businesses and non-profits. INSTRUCTIONS

1. Complete form (typed if possible) and submit a signed copy by email to ev@efficiencymaine.com. The email must be sent by the entity receiving the rebate (not the dealership facilitating the vehicle purchase).
2. If approved, you will receive a letter from Efficiency Maine stating that you are eligible for enhanced rebates as a business or non-profit entity, valid for 12 months.
3. Present the pre-approval letter from Efficiency Maine at a participating Maine dealership to receive an enhanced rebate.
4. (For work vans only) Send vehicle order confirmation to ev@efficiencymaine.com. Funds will be reserved after pre-approval has been granted **and** Efficiency Maine has received confirmation that the vehicle has been ordered (work vans only).
5. Notify Efficiency Maine promptly of any changes to the number and type of vehicles that the entity plans to purchase or lease.
