# **Program Reminders**

- Rebate recipients are required to retain ownership or a lease of the electric vehicle for a minimum of 36 months, except when upgrading to an EV with more electric range. Rebate recipients who do not meet this requirement should return their rebate via check to Efficiency Maine, 168 Capitol St., Suite 1, Augusta, ME 04330.
- Used EV sales only qualify for the <u>Used Clean Vehicle Credit</u> if the dealer reports required information to the buyer AND to the IRS. See the list of required information on the <u>IRS website</u>. Efficiency Maine expects all Participating Dealers to train staff on this topic and perform the necessary steps to enable eligible customers to claim this tax credit.
- At-home charging tip: Many Level 1 (110V) charging cords have multiple amperage settings. Remind new EV owners to check the amperage settings of their charging cord if they're experiencing slow charging.
- Rebate recipients must have received an income verification letter from Efficiency Maine <u>before</u> the vehicle purchase is executed in order to receive the low- or moderate-income rebate amounts.


