- Maine Heat Pumps in National News Congratulations. Maine's heat pump industry is earning national recognition. Here are two recent articles that highlight your good work: <u>The</u> <u>Washington Post</u>, <u>Grist</u>.
- 2) Inflation Reduction Act (IRA) Thanks to the Inflation Reduction Act (IRA), there are now federal tax credits of 30% up to \$2,000 per year for heat pumps, plus 30% up to \$1,200 per year for insulation. Check out efficiencymaine.com for links to details.
- **3)** *Heat Pumps in the Cold Snap* During the first weekend of February 2023, Maine experienced some of the coldest temperatures it had seen in more than five decades. Residents braced themselves for the cold. And heat pump owners wondered: Will my heat pump keep me warm? The short answer is YES!

"It was -20F outside. We were comfortable and our pipes didn't freeze! I pre-set my heat pump at a higher temperature before the cold hit. It did a great job, and I didn't have to use my backup baseboard electric at all." -Manufactured homeowner in Freeport, ME

- 4) *Keeping Heat Pump Registered Technicians Current* Registered Technicians can maintain their active status by reviewing the PDF of our <u>Heat Pumps Basics Module</u>.
- **5)** *Heat Pump HSPF2 Values* While the values are different, our original HSPF and new HSPF2 thresholds are roughly equivalent in terms of efficiency. The new values were selected to ensure the most commonly rebated heat pumps remain rebate-eligible.
- 6) *Homeowner Name on Claim Forms* We use the "Homeowner Name" field on our rebate claim forms for rebate checks so please only enter one name.
- 7) Tool of the Month Our <u>Quick Guide to Home Heating</u> was recently updated to account for current equipment, installation, utility, and fuel costs. It still shows that heat pumps are one of the most cost-effective options for home heating in Maine and the only one that can also provide air conditioning.


