



Eligible Vehicles List

See below for a list of battery electric vehicles (BEVs) and plug-in hybrid electric vehicles (PHEVs) with trim levels that are eligible for an Efficiency Maine rebate. Please note that some qualifying vehicles may not be available in Maine yet. Contact a participating dealer to ask about available models.

To qualify for an Efficiency Maine rebate, a particular vehicle must have a price of no more than the amounts listed below, where the price is defined as total MSRP or "sticker price," including options and accessories, before destination/delivery charges. No other discounts, deductions, credits, or rebates are to be counted in the eligibility determination calculation:

- a. \$80,000 in the case of an eligible pickup truck or commercial van with a gross vehicle weight rating (GVWR) of 6,000 pounds or greater;**
- b. \$50,000 for all other eligible vehicles.**

Federal tax credit information is based on information from the Internal Revenue Service (IRS) and is updated periodically. The information on this page should not be viewed as an official or legally binding document. Other requirements or exceptions may apply. **Note: Federal tax credit requirements changed on January 1, 2024.**
