This training program is designed for the propane and/or natural gas service technician who requires CETP certification to meet State of Maine training requirements for a gas license. The program consists of three courses that are required for the appliance connection and service technician license endorsement: Basic Principles and Practices, Appliance Installation, and Appliance Service. The Large Appliance course meets the training requirement for the Large Appliance gas license endorsement. CETP certification process requires passing the certification exam (included in courses) and skill assessment verification\* for each course.

The skill assessments ARE NOT included in the course.

\* The student's employer provides skill assessment verification. Forms are provided that allow the student's job supervisor to verify on-the-job related skills. State law requires the form be signed by a licensed gas technician. There is no skill assessment for the Large Appliance course.

CETP exam results will not be released until skill assessment verification has been provided.

All book and test costs are included in course fees.
